

Round 7 Performance Period	January 1, 2025 - June 30, 2027







K-12 SWP Application PC Support

- K-12 PC's can help maximize your capacity to submit your grant proposals:
 - Provide Labor Market Information for specific industry sectors or pathways
 - Connect LEAs with community college partners
 - Align the current regional plan and goals to inform grant proposals
 - Provide a final application review before you submit!

K-12 PC's can NOT write or manage your application/grant.







K-12 SWP

Goals, Objectives, & Eligibility







K-12 SWP Goal

"...is to support K-12 LEAs in creating, improving, and expanding CTE... pathways that enable students to successfully transition from secondary education to postsecondary education to living-wage employment" (p. 4 RFA).







K-12 SWP Objectives (p. 5-6 RFA)

- Support Intersegmental Partnerships
 - K-12, Community College, Industry, Workforce Development
- Strengthen CTE Programs (Equity Driven Mindset)
 - Alignment to post-secondary programs for seamless transition
- Refer to Regional Needs
 - Alignment to SWP investments and workforce needs of the region as identified in the OC Regional Plan (p. 6 RFA)
 - Make sure to address the Regional Plan and respond to the needs!







Eligibility Requirements (p. 11-12 RFA)

- Applicants
 - School District, ROCP, COE, Charter
 - No more than 3 applications per LEA
 - Grants may only serve grades 7 − 12
 - Adult Programs: students served are 18 years of age or under
 - Partner with at least one community college (more encouraged)
 - Upload all required documents (review check-list before submitting)
- Match: ROP 1:1 Match
 All Other LEAs 2:1 Match

K-12 SWP OC Investment

- \$70,782,032 Awarded 2018 2024
- 104 Unique K-12 SWP Projects
- Awards by Applicant
 - OCDE: \$28,368,730 = 40% of total funds
 - LEA: \$22,681,213 = 32% of total funds
 - ROP: \$16,496,296 = 23% of total funds
 - Charter: \$3,253,793 = 5% of total funds







K-12 SWP OC Investment

Improvement Strategy Focus

- Curriculum Development = 56% of total funds
- College & Career Exploration = 55% of total funds
- WBL = 51% of total funds
- Postsecondary Transition = 50% of total funds

Categorical Investments

- Staffing = 42% of total funds
- Student Programs = 38% of total funds
- Contract Services = 17% of total funds
- Indirect = 3% of total funds







K-12 SWP OC Investment

Industry Focus

- Information & Communication Technology/DM = 90% of total funds
- Business= 81% of total funds
- Health = 73% of total funds
- Energy, Construction, & Utilities = 65% of total funds







K-12 SWP Round 7 OC Funds

- Funds = \$11,497,537
 - Unemployment Rate, Regional ADA, Job Opening Projections
- LEA ADA Funding Request Bands
 - 1-140 ADA = up to \$250,000
 - 141-550 ADA = up to \$500,000
 - 551-10,000 ADA = up to \$1,000,000
 - Over 10,000 ADA = up to \$2,000,000







Funding Distribution per ADA

"Subsequent funding requests are not intended to sustain programs, rather, are intended to create new CTE programs that feed into a community college..." (p. 51 RFA)

Total Applicants' ADA	Percentage of a Region's Allocation
Less than or equal to 140	4% (\$459,901)
141 - 550	8% (\$919,803)
More than 550	88% (10,117,833)

- 338 occupations met or surpassed research criteria (p. 28 RP)
- 979,203 jobs met at least four of the eight criteria

"All sectors will be focused on...those ranked higher will receive prioritization of resources, if and/or when resources become limited" (p. 40 RP).

Grant applications are scored based on a 101-point scale. A minimum average score of 75 must be obtained to be considered for funding (p. 24)

Detailed strategies to address EQUITY and ACCESS







K-12 SWP Program Objectives

- Program Objectives
 - Align with problem statement
 - Align with post-secondary CTE programming
 - Describe strategies to close specific equity gaps
 - Describe how the pathway/project leads to high-wage, high demand career opportunities (use industry sector analysis for this)







K-12 SWP Project Work Plan

- Project Work Plan
 - Identify K-14 Pathway Quality Strategies
 - Curriculum and Instruction
 - College and Career Exploration
 - Post-secondary Transition
 - Work-based Learning
 - Upload Documents
 - Community College Partner Letter of Support <u>TEMPLATE</u>
 - Leads and all educational partners must sign Statement of Assurance







CTE Work Plan Continued

- Project Work Plan Continued
 - Work Plan:
 - Describe work to be funded by K-12 SWP
 - List project activities and expected outcomes (measurable)
 - Identify partner roles and responsibilities
 - Number of students/teachers to be served (specific)
 - Describe strategies and activities to improve access to and completion of highskill/high-wage CTE opportunities for disproportionately impacted students.
 - Explanation or proposed strategy to leverage other CTE Funds to support work







K-12 SWP Budgets

Budgets

"Each lead LEA and K-12 Partner Agency (if applicable) must prepare a budget by object code, provide descriptions, and identify match funds.

The budget plan should demonstrate measurable and actionable outcomes"

(p. 33 RFA).

Only the lead LEA can request a 4% indirect cost for administrative purposes.







Budgets Continued (p. 33-34 RFA)

- Provide detailed narrative of budget expenditures
- Must supplement not supplant state or local funds
- May not free up state or local dollars
- Identify grant funds distribution strategy
- Financial Match must directly support the proposed project







K-12 SWP Positive Considerations

- Higher Dropout Rate (8.2%) = 2pts
- Special Populations = 2pts
- Unduplicated Pupils = 3pts
- New Vision 2030 CTE Pathway = 3pts
- New K-12 SWP Applicant = 3pts
- Alignment to Vision 2030 = 3pts

Maximum Positive Consideration Points

16pts

OC does not qualify for "Area of Substantial Unemployment" and "Rural School Districts"







CCCCO Vision 2030

Vision 2030 focuses on equity in access and support.

- Equitable Baccalaureate Attainment
 - Early College Credit, Justice Impacted, Foster Youth, Veterans
- Equitable Workforce & Economic Development
 - STEM, Health, Education, Climate Action
- Generative Artificial Intelligence & The Future of Learning
 - Actively engage with AI tools and research to increase learning outcomes

Align with at least one of the strategies to receive positive consideration







Selection Committee Responsibility and Selection Criteria







Selection Committee Responsibilities

- Review LEA K-12 SWP Applications
 - Will not review their own or related application(s)
- Make all Decisions
 - Scoring, selecting grant recipients and award amount
 - Have the discretion to award an amount less than requested
- Right to Reject Applications
 - Incomplete, no alignment to regional needs, submitted late
- May Request Additional Information







Selection Committee Co-Chairs

- Responsibilities (Ed Code 8882-88833)
 - Facilitate training for Selection Committee
 - Assign application review assignments and review scores
 - Score their own batch of applications
 - Design and facilitate Deliberation Meetings
 - Communicate region's funding decisions to Regional Consortia







Selection Committee K-14 TAP

- Responsibilities (Ed Code 8882-88833)
 - Ensure applications are eligible (<u>Eligibility Checklist</u>)
 - Facilitate training for Selection Committee
 - Facilitate weekly check-ins with Selection Committee Chair
 - Answer all questions, comments, and concerns during scoring process

- Student Programming
 - Emphasizes career education activities, programs, and resources designed for students and how the effectiveness of these strategies will be measured.







Student Equity

- Objectives and work plan describe efforts to close equity gaps by improving access to and completion of CTE opportunities for disproportionately impacted students.
- Clearly specify the number of disproportionately impacted students to be served and identify strategies for closing equity gaps from enrollment to job placement.







Equitable Distribution

- Low ADA applications will be funded at 100% of their requested amount per the regional funding distribution identified in the RFA.
- A minimum of one eligible application will be funded per community college district service area.

Regional Collaboration

• Show clear evidence to strengthen career pathway connections between K-12 and post-secondary.







Regional Priorities

- How the application addresses a labor market demand and identifies or demonstrates a strategy for filling the demand.
- How the application includes sectors and pathways that lead to high wage-earning potential and opportunity to reach or exceed a living wage.







Measurable Outcomes

- Objectives and work plan lead to metrics that can be measured through data.
- The impact of the project in terms of the number of students and teachers served, partnerships developed with feeder community college district, community colleges, and employers.
- Demonstrate clear outcomes that lead to post-secondary and living wage jobs.







Budgets

- **Purpose:** Ensure grant funds are to provide extra goods, services, materials, and staff coordination positions that would not otherwise be purchased with state, local, or other non-SWP K-12 funds.
- Plan: Have a detailed plan on how the funds will be used in terms of purchasing equipment, contracting external organizations, staff or instructor salaries, and benefits.







- Budgets Continued
 - **Personnel:** Provide reasonable justification of funds allocated to support staffing (both certificated and classified, including benefits) critical to the management and facilitation of the project objectives and work plan.
 - **Personnel:** No more than 70% of the total budget of an application is allocated for personnel salaries (both certificated and classified, including benefits).
 - Each partner LEA must maintain this criteria throughout the grant cycle.
 - Personnel costs with a direct connection to support students will be prioritized.







- Project Sustainability
 - Includes a brief narrative of how the pathways, teachers, and students impacted in the project will be funded and sustained after the K-12 SWP Round 7 project term ends. The sustainability question is embedded within the Work Plan section under the K-14 Quality Strategy sub-section.

- Activities/Strategies Outcomes are Quantifiable
- Specific Student Equity Plans or Strategies
 - continuation schools, foster youth, ESL
- Ensure Plan Aligns with an OC Priority Sectors
- Consult with Community College Partners
- Detailed & Realistic Budgets (Unique per Education Partner)
- Detailed Description of Partner Roles (College & Industry)
- Focus on Positive Considerations & Selection Criteria

- Complete the entire application & use the <u>Checklist</u>
- Upload the following required documents (p. 35)
 - Statement of Assurance for each K-12 Lead and Partner
